



Swimming Pool Rental Policy

(As of April 1, 2016)

1. All rentals must be scheduled through the Recreation Department.
 - a. Office Hours: Mon-Friday /1:00-5:00pm or by email jhbradley@nephi.utah.gov
 - b. One week notice required for rentals.
2. Pool Hours include: Monday-Friday: 7-10pm & Saturday's: 5:00-10pm.
3. Party groups can have up to 100 participants. There will be an additional \$4 charge per person over 100.
4. Swimming Pool rentals will not be officially scheduled until all fees are paid in full.
5. Nephi Recreation may refuse rental to anyone. Reasons may include but are not limited to: previous non-payment, abuse of facilities in past, bad weather, lack of pool availability, lack of previous supervision, and disregarding policy, etc.
6. Nephi Recreation has the right to cancel rental dates and agreements based on inclement weather. The weather condition will be determined by Recreation Director or Pool Manager. In that instance renter will be able to reschedule use of the pool or receive full refund.
7. Rental groups can bring own outside food. Renter does have the responsibility to clean up afterwards.
8. Pool rentals are available End of May-August.
9. Tobacco, alcoholic beverages and illegal drugs are prohibited at all Nephi City Parks and Facilities. Renter will be expected to keep and enforce Pool rules.

Pool Rental- Fee Schedule:

- a. \$100 for 1 hour Swimming Pool Rental
- b. \$150 for 1 hour Splash Pad Rental
- c. \$200 for 1 hour (Splash Pad and Swimming Pool)

Note: \$4 per person fee will be assessed groups with over 100 participants.
